Letter and Announcement –
Publication of the complete documentation of 9th April 2015**

Dear Prime Minister!

As I had already announced in my letter of the 9th April 2015 for a continued ignoring on your part I herewith submit the complete documentation to the public via internet.

First some clarifications concerning the document attachment Nr.3/Circular Nr. 31/48 of 1st October 1948:

The Canadian High Court renders a remarkable judgment (24th March 1994): The Holocaust revisionist Regina von Finta is acquitted citing that "the mass murder called 'Holocaust' and the KZ gas chambers had never existed". 44

For Austria this constitutes force majeure. Two months later, on the 24th May of the same year, the preliminary proceedings against Emil Lachout have been officially closed. In a statement it says that there was no reason for further judiciary prosecution according to §109(1). 45

This means: A proof for falsification cannot be found, so the Lachout document is deemed genuine. The "gas chamber" in the KZ Mauthausen must be removed. (end of quote)

And:

On the 15th December 1997 the Austrian judiciary has been convicted by the European Human Rights Commission as the last and final authority to pay damages. 49

On the 31st March 1999 the sum is defined 56'000 ÖS that are paid to Emil Lachout on the 1st June 1999 by the Austrian state. (end of quote)

Your persistent silence, dear Prime Minister, will have its reasons. I would like to state again my opinion in this regard, as presented in the document attachment no. 2 of 27th June 2008:

Quote: "I await your correction of the protocol within one week, failing which I must assume that you have acted in accordance with the instructions of political entities at the behest of the CENTRAL COUNCIL OF JEWS IN GERMANY who are acting within the scope of the execution of the still extant Allied Retention Rights under the authoritative influence of the USA and the religious community steering it."

As I had announced in my letter of the 9th April 2015 I understand your silence as an invitation to inform the German and international public.
